Must Have:

Each camper must have **(1)** a Medical Release and Liability Form from Youth for Christ of Imperial Valley if you are under 18; **(2)** Liability Waiver from Snow Summit, regardless of age, if you are going to ski or snowboard; **(3)** a check or cash for the amount of your camp fee. Space is limited but you will be guaranteed a spot if you turn in your \$50 non-refundable deposit on or before January 22.
